through the Early Childhood Division and has served many Tohono
O'odham Children ; and**

**WHEREAS, the Tohono O'odham Legislative Council is desirous of continuing this
program for the benefit of its young members.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council
that it does hereby approve the proposed Budget Modification #2 for
FY 1998 Title XX - Child Day Care Services in the amount of
\$141,349.00.**

**BE IT FURTHER RESOLVED that the duration of the budget will be from July 01,
1997 - June 30, 1998.**

**BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the
Tohono O'odham Nation's officials, to wit: the Chairman and any
designated official are hereby authorized to negotiate and execute the
contract, provided however, that any amendments affecting the
funding levels of this contract shall be submitted for further prior
approval by this Council.**


