

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Budget Modification #1 to Idea Part H (Infants and Toddlers, Birth  
to Three with Disabilities) Fiscal Year 1998)**

**RESOLUTION NO. 98-248**

**WHEREAS, the Tohono O'odham Legislative Council has consistently supported  
all efforts to provide services to children (birth to three years of age)  
with disabilities; and**

**WHEREAS, services for infants and toddlers with disabilities are provided  
throughout the Tohono O'odham Nation; and**

**WHEREAS, the Tohono O'odham Nation has funds through the Bureau of Indian  
Affairs pursuant to Public Law 105-17 which were not expended during  
Fiscal Year 1997 and amendments to allocations during Fiscal Year  
1998 to support services to infants and toddlers with disabilities and  
the Head Start Early Childhood Program has submitted a budget  
modification to support services to infants and toddlers with  
disabilities.**

**NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that it does hereby  
approve the Tohono O'odham Early Childhood Head Start Program's  
request for budget modification #1 to FY 1998 IDEA Part H budget in  
the amount of \$10,298.64**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 26TH,  
day of JUNE, 1998 at a meeting at which a quorum was present with a vote of 1,927.0  
FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested  
in the Council by Section 1(f) of Article VI of the Constitution of the Tohono  
O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and  
approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on  
March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**




