

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(FY 1998 Title XX-Child Day Care Budget July 01,1998 - June 30, 1999)**

**RESOLUTION NO. 98-249**

**WHEREAS, the Tohono O'odham Nation has consistently supported the nurturance of its young members by providing for their welfare through various programs and services designed to meet special needs; and**

**WHEREAS, the Child Day Care Services Program has been successfully operated through the Early Childhood Division and has served many Tohono O'odham Children; and**

**WHEREAS, the Tohono O'odham Legislative Council is desirous of continuing this program for the benefit of its young members.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby approve the proposed Budget for FY 1998-99 Title XX-Child Day Care Services in the amount of \$141,349.00.**

**BE IT FURTHER RESOLVED that the duration of the Budget will be from July 01, 1998 - June 30, 1999.**

**BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's officials, to wit: the Chairman and any designated official are hereby authorized to negotiate and execute the contract, provided however, that any amendments affecting the funding levels of this contract shall be submitted for further prior approval by this Council.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 26TH, day of JUNE, 1998 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


