

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of FY 1998 Community Health Services/Home Health Agency
Budget Modification #2)**

RESOLUTION NO. 98-250

WHEREAS, the Tohono O'odham Nation, Department of Human Services, and Division of Community Health Services are committed to providing uninterrupted Home Health Services for all frail and disabled Elders who need health and social services; and

WHEREAS, the Tohono O'odham Nation recognizes the importance of funding the operational and human resources necessary to provide the highest quality services to elders; and

WHEREAS, the budget modification #2 is necessary to cover increased operational costs.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:

- 1. It hereby approves the attached budget modification #2 and authorizes expenditures in accordance with the budget submitted by Community Health Services.**
- 2. The Tohono O'odham Nation Officials, to wit: the Chairman and Vice Chairman and any designated Official are hereby authorized to negotiate and execute contracts associated with this grant.**

The foregoing Resolution was passed by the Tohono O'odham Council on the 26TH day of JUNE, 1998 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


