for 661.00 Mileage POV and 860.00 Special Activities; and**

**WHEREAS, the modification to Administrative Costs also includes the deletion of
line item 751.00 Lease Rentals, and the movement of available funds
into other line items; and**

**WHEREAS, the Classroom Training Budget has been modified to move some costs
into the Training Assistance budget which results in the deletion of
line items 630.00 Insurance, 650.00 Tuition & Registration, 661.00
Mileage POV, 710.00 Utilities, 711.00 Communications Expense, 712.00
Gas, Oil & Coolants, 751.00 Lease Rentals, 771.00 Repair &
Maintenance-Vehicle, and 772.00 Repair and Maintenance-Building;
and**

**WHEREAS, the Classroom Training Budget reflects an additional item for 750.00
Capital/Equipment Purchase; and**

**WHEREAS, the program has added an additional cost category by shifting costs
into a Training Assistance budget in order to ease financial reporting
requirements, the Training Assistance budget totals \$129,482.00; and**

**WHEREAS, a modification to the Support Services budget reflects movement of
available funds between line items.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council
does hereby approve the 1997 JTPA Title IVA Administrative Costs
budget modification #2, Classroom Training budget modification #3,**


