4 **WHEREAS, an Initiative, No. IN-01-97 (the "Initiative"), was approved by the voters**  
5 **of the Tohono O'odham Nation on June 28, 1997; and**

6 **WHEREAS, pursuant to Legislative Council Resolution 97-435, the Nation entered**  
7 **into an Attorney Contract with the law firm of Raven & Kirschner (the**  
8 **"Attorneys") to assist the Office of Attorney General in assessing the tax**  
9 **implications for the Nation and its members associated with the**  
10 **implementation of the Initiative; and**

11 **WHEREAS, the Attorney Contract is in the amount of \$10,000 and expires on**  
12 **September 30, 1998; and**

13 **WHEREAS, additional funding is required for the Attorney Contract to protect the**  
14 **Nation's interests in these matters during fiscal year 1998; and**

15 **WHEREAS, by Resolution 97-518, the Legislative Council approved a budget in the**  
16 **amount of \$50,000 [Account No. 1-1809(810)] for legal costs related to**  
17 **the implementation of the Initiative (the "Legal Administrative**  
18 **Budget"); and**

20 **WHEREAS, the Attorney General recommends amending the Attorney Contract**  
21 **to increase the Contract amount by \$12,000; and**

22 **WHEREAS, sufficient funds are available in the Legal Administrative Budget for**  
23 **this purpose; and**

24 **WHEREAS, the Domestic Affairs Committee recommends approval by the**  
25 **Legislative Council of Amendment No. 1 to the Attorney Contract to**  
26 **increase the Contract amount by \$12,000.**

- 1. The Tohono O'odham Legislative Council hereby approves Amendment No. 1 to the Attorney Contract with the law firm of Raven & Kirschner, in the form attached hereto, which increases the Contract amount by \$12,000 payable from the Legal Administrative Budget [Account No. 01-1809(810)].**
- 2. The Chairman of the Nation is authorized and directed to execute Amendment No. 1 to the Attorney Contract.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 06TH day of JULY, 1998 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 2(a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


