WHEREAS, by Resolution 97-434 the Tohono O'odham Legislative Council approved an Attorney Contract with the law firm of Quigley, Tang & Whitehill (the "Attorneys") to provide legal representation with respect to certain bankruptcy proceedings affecting the Nation's interests, and litigation and negotiations related to the Central Arizona Project; and

WHEREAS, the Attorney Contract is in the amount of \$50,000 for fiscal year 1998; and

WHEREAS, the additional sum of \$40,000 is required for legal fees and expenses to assure uninterrupted legal representation in these matters; and

WHEREAS, the operating budget of the Office of Attorney General for fiscal year

1998 includes sufficient funding to supplement the Attorney Contract
in such amount; and

WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative Council of Amendment No. 1 to the Attorney Contract to increase the Contract amount by \$40,000.

NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The Tohono O'odham Legislative Council hereby approves Amendment No. 1 to the Attorney Contract with the law firm of Quigley, Tang & Whitehill, in the form attached hereto, which increases the Contract amount by \$40,000, payable from the fiscal year 1998 operating budget of the Office of Attorney General.
- 2. The Chairman of the Nation is authorized and directed to execute Amendment No. 1 to the Attorney Contract.
