4	WHEREAS,	on June 28, 1997 the voters of the Tohono O'odham Nation (the
5		"Nation") approved Initiative No. IN-01-97 (the "Initiative"); and
6	WHEREAS,	the Initiative authorized funding from Gaming Revenues for several
7		measures, including a one-time per capita distribution of \$2,000 to
8		each member of the Nation enrolled on June 28, 1997 (the "Initial Per
9		Capita Distribution"); and
10	WHEREAS	pursuant to Resolution 97-451, the Legislative Council adopted an
11	WILLIAM,	
12		Initiative Funding and Implementation Plan (the "FIP") which
13		authorized the establishment of set-aside accounts for the Initial Per
14		Capita Distribution and other Initiative measures, and set certain
15		conditions on the expenditure of funds from such accounts; and
16	WHEREAS,	by Resolution 97-478, the Legislative Council approved the transfer of
17		funds from the Desert Diamond Savings Account to certain designated
18 19		set-aside accounts established at Bank of America Arizona, including
20		the sum of \$41.5 million to set-aside account no. 3030425-1067524 for
21		the Initial Per Capita Distribution (the "Per Capita Account"); and

23	WHEREAS,	three of the conditions to expenditure of the Per Capita Account
24		specified in the FIP are (1) approval by the Secretary of the Interior of
25		a per capita distribution plan (the "Revenue Allocation Plan")
26		pursuant to the requirements of the Indian Gaming Regulatory Act, 25
27		U.S.C. § 2710 (b) (3); (2) acceptance by the Legislative Council of a
28		Certification of Eligible Members submitted by the Enrollment Office

**RESOLUTION NO. 98-278** (Accepting Certification of Eligible Members and Authorizing the Expenditure of Funds for Per Capita Payments under the Initiative) 1 Page 2 of 5 2 and based upon receipt of a properly completed and filed Certificate 3 of Eligibility Verification for Per Capita Payment for each member; 4 5 and (3) as to each Minor Eligible Member, establishment of a restricted 6 account at Bank of America for deposit of such member's per capita 7 payment; and 8 WHEREAS, pursuant to Resolution 97-452, the Legislative Council adopted a 9 Revenue Allocation Plan and caused the Plan to be submitted for 10 approval by the Phoenix Area Office of the Bureau of Indian Affairs in 11 accordance with authority delegated to the Area Office by the 12 13 Secretary of the Interior; and 14 WHEREAS, by letter dated December 18, 1997, the Area Office approved the 15 Revenue Allocation Plan with respect to the Initial Per Capita 16 Distribution and disapproved the Plan with respect to the Biennial Per 17 Capita Payments; and 18 WHEREAS, an agreement with Bank of America has not yet been finalized for the 19 establishment of the restricted accounts which is required as a 20 21 condition to disbursement of the Initial Per Capita Distribution to 22 such accounts for Minor Eligible Members; and 23 WHEREAS, pursuant to Resolution Nos. 97-525, 98-010, 98-037, 98-084, 98-192 and 24 98-207, the Legislative Council accepted and approved Certifications 25 of Eligible Members for the Initial Per Capita Distribution, and 26 disbursements have been made to such Members; and 27 WHEREAS, the Enrollment Office has filed with the Legislative Council a 28

WHEREAS, all conditions under the laws of the United States and the Nation have 5 been satisfied to permit the disbursement of the Initial Per Capita Distribution to the members listed in the Certification of Eligible 8

NOW, THEREFORE, BE IT RESOLVED THAT:

Members.

1. The Tohono O'odham Legislative Council hereby accepts and approves the Certification of Eligible Members, in the form attached hereto.

Certification of Eligible Members listing 61 adult members who are

eligible for receipt of the Initial Per Capita Distribution; and

2. The Legislative Council authorizes (a) the transfer of the sum of \$122,000 from the Per Capita Account to the special checking account no. 252-350-324 established at Bank of America Arizona (the "Per Capita Checking Account"); and (b) upon the joint signature of the Chairman and Vice Chairman of the Nation, issuance of a check on the Per Capita Checking Account in the amount of (i) \$2,000 to each Eligible Member who is a resident or citizen of the United States and is listed in the attached Certification of Eligible Members and (ii) \$1,400 to each Eligible Member who is not a resident or citizen of the United States and is listed in the attached Certification, with the balance of \$600 withheld and remitted to the Internal Revenue Service pursuant to the requirements of federal law.
