

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Tohono O'odham Utility Authority Right-of-Way, Little Tucson
Community, Baboquivari District, Tohono O'odham Nation)**

RESOLUTION NO. 98-283

WHEREAS, by Resolution No. 08-70 the Nation established the Papago Tribal Utility Authority, now known as Tohono O'odham Utility Authority (TOUA), for purposes of constructing, maintaining and operating various utility systems within the Nation to be owned wholly by the Nation; and

WHEREAS, the Tohono O'odham Legislative Council on 10 December 1990 did pass Resolution No. 447-90 (Amending the Restated Plan of Operation of the Tohono O'odham Utility Authority) and Resolution No. 97-175 (Adopting Second Restated Plan of Operation for the Tohono O'odham Utility Authority) which requires the Authority to submit for prior review and approval of the Legislative Council and each affected District any proposed utility easement; and

WHEREAS, TOUA requests permission for a Right-of-Way to extend the Water System and related facilities to an approved homesite within Little Tucson Community, Baboquivari District, Tohono O'odham Nation; and

WHEREAS, TOUA has respectfully submitted all documents and pertinent information (attached hereto and incorporated herein by reference) for uses consistent with the authorized purposes of TOUA; and

WHEREAS, the new waterline extension and related facilities will be of substantial benefit to the Little Tucson Community, Baboquivari District, the Tohono O'odham Nation and their respective members; and

3 **WHEREAS, on 23 June 1998 the Natural Resources Committee reviewed the**
4 **proposed Right-of-Way and recommends approval thereof by the**
5 **Tohono O'odham Legislative Council.**

6 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council**
7 **does hereby approve the Right-of-Way as requested by TOUA to extend**
8 **the existing water system and related facilities for the location (as**
9 **more fully described in the attached map and legal description) and**
10 **construction by TOUA or its designated subsidiaries for uses**
11 **consistent with the authorized purposes of TOUA.**

12 **The foregoing Resolution was passed by the Tohono O'odham Council on the 08TH**
13 **day of JULY, 1998 at a meeting at which a quorum was present with a vote of 1,927.0**
14 **FOR; -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested**
15 **in the Council by Section 1(i) of Article VI of the Constitution of the Tohono O'Odham**
16 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved**
17 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,**
18 **1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


