

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving a Budget of \$2,595,241 to fund intergovernmental
and Public Relations)**

RESOLUTION NO. 98-290

WHEREAS, it is in the interest of the Nation to put in place and fund a comprehensive plan for public relations and garnering political support on issues of concern to the Nation; and

WHEREAS, the Chairman of the Nation has estimated that such a plan shall cost at least \$2,595,241 through Fiscal Year 1999; and

WHEREAS, the Chairman of the Nation has submitted such a plan for consideration by the Legislative Council and has consulted with the District Chairmen that funding such a plan be appropriated from savings set aside from gaming revenues; and

WHEREAS, the Chairman has proposed budgets for expenditure of such funds in this and through subsequent fiscal years.

NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The proposal for intergovernmental and public relations as submitted by the Chairman of the Nation is hereby approved.**
- 2. The sum of \$2,595,241 is hereby appropriated from savings set aside from gaming revenues.**
- 3. Of the amounts so appropriated, \$2,095,241 are directed to the operating account of the Executive Office for expenditure in and through both Fiscal Year 1998 and Fiscal Year 1999 in accordance with the proposed budget, and \$500,000 are directed to the operating account of the Office of the Attorney General for expenditure in and through both Fiscal Year 1998 and Fiscal Year 1999 in accordance with the proposed budget.**
