3 officers of the Tohono O'odham Nation reduce this final
4 determination in writing regarding each of the foregoing applications
5 for enrollment in accordance with Section 3(c) of Article III of the
6 Enrollment Ordinance; give notice of this Council's determination in
7 accordance with Section 4 of Article III of the Enrollment Ordinance;
8 and place the names of each applicant upon the membership roll of
9 the Tohono O'odham Nation in accordance with Article V of the
10 Enrollment Ordinance.

12 The foregoing Resolution was passed by the Tohono O'Odham Legislative Council
13 on the 03RD day of AUGUST, 1998 at a meeting at which a quorum was present with
14 a vote of 1,620.0 FOR; -0- AGAINST; -0- NOT VOTING; and 307.0 [06] ABSENT, pursuant
15 to the powers vested in the Council by Section 1 of Article II and Section 1(h) of
16 Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
17 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
18 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
19 the Act of June 18, 1934 (48 Stat. 984).
