4 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it**  
5 **does hereby recognize that the above-named person(s) have relinquished their**  
6 **membership in this Nation, and does hereby order that their name(s) be deleted**  
7 **from the membership roll.**

8 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the**  
9 **03RD. Day of AUGUST, 1998 at a meeting at which a quorum was present with a vote of 1,620.0**  
10 **FOR; -0- AGAINST; -0- NOT VOTING; and 307.0 [05] ABSENT, pursuant to the powers vested in**  
11 **the Council by Article II, Section 3 and Article IV, Section 1 (h) of the Constitution of the**  
12 **Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and**  
13 **approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,**  
14 **1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


