

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving San Lucy District Elderly Program Projects and Appropriating
\$204,154 from P.L. 99-503 Funds)**

RESOLUTION NO. 98-297

WHEREAS, in 1986, the United States Congress enacted Public Law 99-503 "Gila Bend Indian Reservation Lands Replacement Act" to provide funds "to be used for the benefit of the San Lucy District"; and

WHEREAS, the San Lucy Elderly Program and Advisory Council are concerned about the health and safety of elderly members did solicit project proposals on their needs, and did submit three (3) projects to the San Lucy District Council for review and approval further requesting that P.L. 99-503 funds be used to pay for the projects.

1. Bathroom Renovations \$135,819

2. Cooling Systems (A/C) \$ 56,000

3. Security Doors \$ 12,335

TOTAL \$204,154; and

WHEREAS, by Resolution No. SL 07-54-98, the San Lucy District Council approved the proposals submitted by San Lucy Elderly Program and Advisory Council for the elderlies and requests the Tohono O'odham Nation Legislative Council to appropriate P.L. 99-503 monies in the amount of \$204,154 for the projects; and

WHEREAS, the Budget and Finance Committee of the Legislative Council did review and approve the request from San Lucy District on 23 July 1998 and recommends to the Tohono O'odham Nation Legislative Council that it would be in the best interest of San Lucy District to appropriate P.L. 99-503 monies in the amount of \$204,154 for the projects.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves the San Lucy District Elderly Program Projects in the

amount of \$204,154.

BE IT FURTHER RESOLVED that the amount of \$204,154 be appropriated from P.L. 99-503 account using only the interest.

BE IT FINALLY RESOLVED that the funds be wire transferred to the San Lucy District Community First Bank Gila Bend Branch (General) account, account No. 8221861432.

The foregoing Resolution was passed by the Tohono O'odham Council on the 03RD day of AUGUST, 1998 at a meeting at which a quorum was present with a vote of 1,620.0 FOR; -0- AGAINST; -0- NOT VOTING; and 307.0 [05] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


