**RESOLUTION NO. 98-299**

**WHEREAS, by Resolution No. 98-290, the Legislative Council authorized an appropriation of \$500,000.00 to the operating account of the Office of the Attorney General for expenditure in and through both Fiscal Year 1998 and Fiscal Year 1999 in accordance with the proposed budget; and**

**WHEREAS, the budget referred to in Resolution No. 98-290 is attached hereto and incorporated herein by this reference.**

**NOW, THEREFORE, BE IT RESOLVED THAT the attached budget is the budget approved pursuant to Resolution No. 98-290 for expenditure of the monies appropriated in that Resolution for the Office of the Attorney General.**


**The foregoing Resolution was passed by the Tohono O'odham Council on the 03RD day of AUGUST, 1998 at a meeting at which a quorum was present with a vote of 1,170.0 FOR; 450.0 AGAINST; -0- NOT VOTING; and 307.0 [05] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
