RESOLUTION NO. 98-302

WHEREAS, the Gu Achi District Council has reviewed and considered to make a second amendment to its FY -98 budget; and

WHEREAS, the Gu Achi District FY - 98 budget was \$717,500.35 and it will be amended by an increase of \$11,715.71, totaling a new budget amount of \$729,216.09; and


WHEREAS, the Gu Achi District does have sufficient funds to cover the amendment in the amount of \$11,715.71; and

WHEREAS, the Tohono O'odham Legislative Council has reviewed and proposed budget amendment and approves the same.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby approves the Gu Achi District Council budget amendment in accordance with the attached budget.


The foregoing Resolution was passed by the Tohono O'odham Council on the 04TH day of AUGUST, 1998 at a meeting at which a quorum was present with a vote of 1,766.0 FOR; -0- AGAINST; -0- NOT VOTING; and 161.0 [08] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
