

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Tohono O'odham Nation JTPA/NEW Department of Labor Title
IVA Budget 1998)**

RESOLUTION NO. 98-304

WHEREAS, the Tohono O'odham Nation has received planning guidance and instruction for the Fiscal Year 1998 Department of Labor Title IVA; and

WHEREAS, the Tohono O'odham Nation has been determined eligible to receive funding for the Job Training Partnership Act/Native Employment Works Program; and

WHEREAS, the Tohono O'odham Nation is eligible to receive a grant in the amount of \$459,405.00; and

WHEREAS, the services provided through the Job Training Partnership Act/Native Employment Works Program will assist individuals in upgrading job skills and to actively seek employment on a permanent basis.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Nation will greatly benefit from these individuals when they are trained and are employable.

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation Officials, to wit: the Chairman and any designated official are hereby authorized to negotiate and execute the contract, provided however, that any amendment affecting the funding or funding levels of this contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 04TH day of AUGUST, 1998 at a meeting at which a quorum was present with a vote of 1.738.0 FOR; -0- AGAINST; -0- NOT VOTING; and 189.0[08] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


