1 **RESOLUTION NO. 98-306** 2 3 WHEREAS, the Tohono O'odham Nation JTPA/NEW program has received notice of 4 allocation with funds available to the Nation in the amount of 5 \$175,073.00; and 6 7 WHEREAS, the Tohono O'odham Nation previously submitted a contract based on 8 planning figures in the amount of \$147,216.00; and 9 WHEREAS, the contract has been returned to the Nation to adjust the amount 10 reflecting an increase in available funds. 11 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council 12 does hereby approve the 1998 Title IIB Budget and the adjustment to 13 the Intergovernmental Agreement between the State of Arizona and the 14 Tohono O'odham Nation for 1998. 15 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the 16 Tohono O'odham Nation's Officials, to wit: the Chairman and any 17 designated official are hereby authorized to negotiate and execute the 18 contract, provided however, that any amendment affecting the funding 19 or funding levels of this contract shall be submitted for further prior 20 approval by this Council. 21 22 23 The foregoing Resolution was passed by the Tohono O'odham Council on the <u>04TH</u> day of AUGUST, 1998 at a meeting at which a quorum was present with a vote of 24 1,927.0 FOR: -0- AGAINST: -0- NOT VOTING: and [06] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono 25 O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on 26 March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). 27 28
