

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the JTPA/NEW 1998 Budget for Title IIC)**

**RESOLUTION NO. 98-307**

**WHEREAS, the Tohono O'odham Nation JTPA/NEW program has received notice of allocation with funds available to the Nation in the amount of \$21,249.00; and**

**WHEREAS, the Tohono O'odham Nation previously submitted a contract based on planning figures in the amount of \$18,321.00; and**

**WHEREAS, the contract has been returned to the Nation to adjust the amount reflecting an increase in available funds.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby approve the 1998 Title IIC Budget and the adjustment to the Intergovernmental Agreement between the State of Arizona and the Tohono O'odham Nation for 1998.**

**BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's Officials, to wit: the Chairman and any designated official are hereby authorized to negotiate and execute the contract, provided however, that any amendment affecting the funding or funding levels of this contract shall be submitted for further prior approval by this Council.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 04TH day of AUGUST, 1998 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


