

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 1998 Division of Alcoholism & Substance Abuse Budget Modification
Number One)**

RESOLUTION NO. 98-309

WHEREAS, the Tohono O'odham Nation Department of Human Services is presently operating the Division of Alcoholism and Substance Abuse Program Component under P.L. 93-638 Master Health Contract with the Public Health, Indian Health Services; and

WHEREAS, the Grants and Contracts Office has notified the Division of Alcoholism & Substance Abuse Program of carry over funds available for obligation under FY 98 Master Health contract; and


WHEREAS, a budget modification has been prepared for review and approval by the Division of Alcoholism & Substance Abuse to utilize \$1,235,411.34 of the contract carryover amount to cover expenditures.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:

- 1. It hereby approves and authorizes the modification in accordance with the attached budget.**
- 2. The Tohono O'odham Nation's Officials to wit: the Chairman and Vice Chairman and any designated official are hereby authorized to negotiate and execute the contract.**

The foregoing Resolution was passed by the Tohono O'odham Council on the 04TH day of AUGUST, 1998 at a meeting at which a quorum was present with a vote of 1.318.0 FOR; -0- AGAINST; -0- NOT VOTING; and 609.0[11] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


