cover for the fiscal year.**

**NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does hereby  
approve the Budget for 1998-99 for the Sif-Oidak District in the amount  
of \$881,318.00.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 05TH  
day of AUGUST, 1998 at a meeting at which a quorum was present with a vote of  
1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers  
vested in the Council by Section 1(d)(3) of Article VI of the Constitution of the Tohono  
O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and  
approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on  
March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
