RESOLUTION NO. 98-322

**WHEREAS, the US Environmental Protection Agency (USEPA), Region IX Superfund
Division announced there is available funding in the amount of \$80,000
for implementation of a Preliminary Assessment/Site Inspection
program for the Tohono O'odham Nation; and**

**WHEREAS, the Tohono O'odham Nation prepared a grant application to EPA,
Region IX Superfund Division for Cooperative Agreement Funds to
implement the Preliminary Assessment/Site Inspection program; and**

**WHEREAS, the Cooperative Agreement Funds will allow the Nation to identify
potentially hazardous waste sites and work cooperatively with EPA,
Region IX Superfund Division to determine whether the sites meet
Superfund eligibility; and**

**WHEREAS, the establishment of a Preliminary Assessment/Site Inspection
Program will allow the Nation to address potentially hazardous waste
sites and assist in the Nation's efforts to protect and maintain the
environment for the well being of the Nation's members.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council
(Council) hereby approves the Tohono O'odham Nation Preliminary
Assessment/Site Inspection Program Cooperative Agreement Grant
Application to EPA, Region IX Superfund Division.**

**BE IT FURTHER RESOLVED that the Council accepts the grant funding that EPA has
reserved for the Tohono O'odham Nation.**

BE IT FINALLY RESOLVED that the Council approves the attached budget and

The foregoing Resolution was passed by the Tohono O'odham Council on the 05TH day of AUGUST, 1998 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


