NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council
hereby approves of the Fresnal Canyon budget in the amount of nine
hundred dollars and no cents (\$900.00).


BE IT FURTHER RESOLVED that the line items with budgeted amounts are:

1,807.0 FOR; -0- AGAINST; -0- NOT VOTING; and 120.0 [07] ABSENT, pursuant to the
powers vested in the Council by Section 1(d)(3) of Article VI of the Constitution of the
Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18,
1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
Stat. 984).


