

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Accounting Department's Modification #2 and the Transfer
of Capital Funds to the Capital Account, 01-1044)**

RESOLUTION NO. 98-343

WHEREAS, the Accounting Department has prepared a modification of its FY 98 budget to reallocate identified savings for upgrading its computers for the Year 2000 compliance; and

WHEREAS, the allocation of capital funds from the Department's operational budget requires that these funds be transferred to the Executive Branch's designated Capital Account, 01-1044; and

WHEREAS, the modification has been presented to the Budget and Finance Committee for review and recommendation; and

WHEREAS, the Budget and Finance Committee recommends approval of the Accounting Department's FY 98 budget modification #2 and the transfer of capital funds to the Executive Branch's designated Capital Account, 01-1044 as attached.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby approves the attached budget modification #2 of the Accounting Department, including the transfer of capital funds to the Executive Branch's Capital Account, 01-1044, and authorizes the expenditures as provided.

BE IT FURTHER RESOLVED that the transfer of capital funds to the Capital Account does not affect the Accounting Department's Base Budget amount.

The foregoing Resolution was passed by the Tohono O'odham Council on the 01ST day of SEPTEMBER 1998 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
