

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Baboquivari District, Choulic Community FY-98 Budget Amendment)**

**RESOLUTION NO. 98-353**

**WHEREAS, by Resolution 97-407 the Tohono O'odham Legislative Council did approve Baboquivari Districts' FY-98 budget; and**

**WHEREAS, by Resolution 98-B-117 the Baboquivari District Council did approve of a budget amendment for the Choulic Community's FY-98 budget in the amount of fourteen thousand five hundred eighty eight dollars and six cents (\$14,588.06); and**

**WHEREAS, the fourteen thousand five hundred eighty eight dollars and six cents (\$14,588.06) will be distributed to line item 750 Capitol Equipment; and**

**WHEREAS, any changes in the funding level or purposes of funding is to be reviewed and approved by the Tohono O'odham Legislative Council; and**

**WHEREAS, Baboquivari District does have sufficient funds in their District account for Choulic Community's Budget Amendment.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves Baboquivari District's Choulic Community FY-98 Budget Amendment in the amount of fourteen thousand five hundred eighty eight dollars and six cents (\$14,588.06).**

**BE IT FURTHER RESOLVED that the fourteen thousand five hundred eighty eight dollars and six cents (\$14,588.06) will be distributed to line item 750 Capital Equipment.**


