**WHEREAS, the Tohono O'odham Nation is presently operating the P.L. 93-638
contract with the Bureau of Indian Affairs under a three (3) year Master
contract with FY 98 being the second year; and**


**WHEREAS, such tribal operations have been successful and beneficial to the Tohono
O'odham Nation and its members; and**

**WHEREAS, the Bureau of Indian Affairs has allocated additional monies for the
Employment Assistance Program to the Tohono O'odham Nation in the
amount of \$15,659.00 for FY 98.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council
authorizes the expenditures of these funds according to the attached
budget modification for the Employment Assistance Program.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 14TH day
of SEPTEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,927.0
FOR; -0- AGAINST; -0- NOT VOTING; and (01) ABSENT, pursuant to the powers vested in
the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham
Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by
the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
