

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Appointment of Paul Andrew to the Election Board for a Four Year Term)**

**RESOLUTION NO. 98-361**

**WHEREAS, Article II, Section 1B of the Tohono O'odham Uniform Election Ordinance empowers the Legislative Council to appoint members to the Election Board; and**

**WHEREAS, Board Member, Paul Andrew's term expired on July 31, 1998, as to the appointment letter which Mr. Andrew was given a four year term; and**

**WHEREAS, the Election Board does hereby recommend the reappointment of Mr. Paul Andrew; and**

**WHEREAS, the Rules Committee has announced and interviewed for the vacant position on the Board and recommends the reappointment of Paul Andrew to another four year term.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby reappoints Paul Andrew to a four year term on the Election Board commencing August 01, 1998 and ending July 31, 2002.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 14TH, day of SEPTEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,605.0 FOR; 322.0 AGAINST; -0- NOT VOTING; and (0) ABSENT, pursuant to the powers vested in the Council by Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
