

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of JTPA/NEW Program FY 1998 Department of Labor - Title IIB
Budget Modification #1)**

RESOLUTION NO. 98-369

WHEREAS, the original budget for the FY 1998 Department of Labor Title IIB was in the amount of \$300,018.00; and

WHEREAS, a decrease in projected carry over funds in the amount of \$5,605.00 for a budget adjusted amount of \$294,413.00; and

WHEREAS, the purpose of the Tohono O'odham Nation JTPA/NEW Program is to provide training and support services to eligible Native Americans residing on the Tohono O'odham Nation; and

WHEREAS, additional line items have been included to facilitate comprehensive spending levels between cost shared budgets.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby approves the JTPA/NEW Budget Modification #1 for the Department of Labor Title IIB FY 1998.

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's Officials, to wit: the Chairman and any designated official are hereby authorized to negotiate and execute the contract, provided however, that any amendment affecting the funding or funding levels of this contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 15TH day of SEPTEMBER, 1998 at a meeting at which a quorum was present with a vote of 1.927.0 FOR; -0- AGAINST; -0- NOT VOTING; and (06) ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
