1 2 RESOLUTION NO. 98-369 3 WHEREAS, the original budget for the FY 1998 Department of Labor Title IIB was in 4 the amount of \$300,018.00; and 5 WHEREAS, a decrease in projected carry over funds in the amount of \$5,605.00 for a 6 7 budget adjusted amount of \$294,413.00; and 8 WHEREAS, the purpose of the Tohono O'odham Nation JTPA/NEW Program is to 9 provide training and support services to eligible Native Americans 10 residing on the Tohono O'odham Nation; and 11 WHEREAS, additional line items have been included to facilitate comprehensive 12 spending levels between cost shared budgets. 13 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that 14 it hereby approves the JTPA/NEW Budget Modification #1 for the 15 Department of Labor Title IIB FY 1998. 16 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono 17 O'odham Nation's Officials, to wit: the Chairman and any designated 18 official are hereby authorized to negotiate and execute the contract, 19 provided however, that any amendment affecting the funding or funding 20 levels of this contract shall be submitted for further prior approval by this 21Council. **22** 23 The foregoing Resolution was passed by the Tohono O'odham Council on the 15TH. day of SEPTEMBER, 1998 at a meeting at which a quorum was present with a vote of 1.927.0 24 FOR; <u>-0-</u> AGAINST; <u>-0-</u> NOT VOTING; and <u>(06)</u> ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham 25 Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, 26 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). 27
