

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the JTPA/NEW Program Policies & Procedures Manual)**

RESOLUTION NO. 98-371

WHEREAS, the Tohono O'odham Nation JTPA/NEW Program has incorporated guidance and instructions in regulations from funding sources Department of Labor, State of Arizona, and the Service Delivery Area; and

WHEREAS, the Tohono O'odham Nation JTPA/NEW Program has incorporated guidance and instruction in policies and procedures from many Tohono O'odham Nation Departments and Programs in concurrence with the regulations from the Nation's Human Resource Department; and

WHEREAS, the Tohono O'odham Nation JTPA/NEW Program Policies & Procedures Manual is a well developed program manual for both participants and employees.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby approves the JTPA/NEW Program Policies & Procedures Manual.

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's Officials, to wit; the Chairman and any designated official are hereby authorized to negotiate and execute this manual, provided however, that any amendment affecting the Program Policies & Procedures shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 16TH day of SEPTEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and (06) ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
