1 $\mathbf{2}$ **RESOLUTION NO. 98-371** 3 WHEREAS, the Tohono O'odham Nation JTPA/NEW Program has incorporated 4 guidance and instructions in regulations from funding sources 5 Department of Labor, State of Arizona, and the Service Delivery Area; and 6 WHEREAS. the Tohono O'odham Nation JTPA/NEW Program has incorporated 7 guidance and instruction in policies and procedures from many Tohono 8 O'odham Nation Departments and Programs in concurrence with the 9 regulations from the Nation's Human Resource Department; and 10 WHEREAS, the Tohono O'odham Nation JTPA/NEW Program Policies & Procedures 11 Manual is a well developed program manual for both participants and 12 employees. 13 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that 14 it hereby approves the JTPA/NEW Program Policies & Procedures 15 Manual. 16 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the 17 Tohono O'odham Nation's Officials, to wit; the Chairman and any 18 designated official are hereby authorized to negotiate and execute this 19 20 manual, provided however, that any amendment affecting the Program 21 Policies & Procedures shall be submitted for further prior approval by **22** this Council. 23 24

The foregoing Resolution was passed by the Tohono O'odham Council on the 16TH. day of SEPTEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and (06) ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
