

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Rescinding Resolution No. 13-84 Which Sanctioned the Introduction,  
Sale, Possession and Consumption of Spirituous Liquor in  
Sif Oidak District)**

**RESOLUTION NO. 98-376**

**WHEREAS, on September 16, 1998 the Tohono O'odham Nation Saint Francis Feast Committee and the District Chairperson of Sif Oidak District requested that the Tohono O'odham Legislative Council pass a resolution supporting the Sif Oidak District Council request for temporary waiver of Ordinance 05-82 from September 20, 1998 to October 5, 1998 for the Feast of Saint Francis in Anegam Village; and**

**WHEREAS, the Tohono O'odham Legislative Council defeated the proposed resolution supporting the temporary waiver; and**

**WHEREAS, the Tohono O'odham Legislative Council then passed a motion to rescind the Resolution of the Papago Tribal Council No. 13-84 "Sanctioning Spirituous Liquor in Sif Oidak District."**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution of the Papago Tribal Council No. 13-84 "Sanctioning Spirituous Liquor in Sif Oidak District" is hereby rescinded.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 16TH day of SEPTEMBER, 1998 at a meeting at which a quorum was present with a vote of 887.0 FOR; 799.0 AGAINST; 241.0 NOT VOTING; and (03) ABSENT, pursuant to the powers vested in the Council by Section 1 (c)(1) & (2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**




