RESOLUTION NO. 98-381

**WHEREAS, the HICKIWAN District Council met on September 12, 1998 to discuss their
FY 99 Budget; and**

**WHEREAS, the HICKIWAN District Council is requesting for a continuance of FY 98
Budget to allow the District Council more time to review the FY 99 Budget
for its approval; and**

**WHEREAS, HICKIWAN District does have sufficient funds to cover District costs in the
Everen account and Bank of America account; and**

**WHEREAS, the HICKIWAN District FY 99 Budget will be presented at the October
Session of the Legislative Council.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does
support the HICKIWAN District request for continuing use of FY 98 Funds
until FY 99 Budget is in place.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 17TH, day
of SEPTEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,652.0
FOR; -0- AGAINST; -0- NOT VOTING; and 275.0 (08) ABSENT, pursuant to the powers vested
in the Council by Section 1 (d)(2) & (3) Article VI of the Constitution of the Tohono
O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and
approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March
6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
