**RESOLUTION NO. 98-382**

**WHEREAS, the Tohono O'odham Nation is presently operating the Department of Human Services-Divisions of Family Assistance and Child Welfare under an FY1998, P.L. 93-638 master contract with the Bureau of Indian Affairs; and**

**WHEREAS, any amendments affecting the funding or funding levels of the contract shall be submitted for review and approval by the Tohono O'odham Legislative Council; and**

**WHEREAS, an amendment has been submitted for review and approval by the Department of Human Services-Family Assistance/Child Welfare Divisions.**

**NOW, THEREFORE, BE IT RESOLVED:**

- 1. That the Tohono O'odham Legislative Council authorizes the expenditures of these funds according to the attached budget modification number 1 for the following divisions: Family Assistance and Child Welfare.**
- 2. The Tohono O'odham Nation's officials to wit: the Chairman and Vice Chairman and any designated official are hereby authorized to negotiate and execute the contract.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 17TH, day of SEPTEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,813.0 FOR; ~~0~~ AGAINST; ~~0~~ NOT VOTING; and 114.0 (06) ABSENT, pursuant to the powers vested in the Council by Section 1 (f) Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
