

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of FY 1999 Community Health Services/Home Health Agency
Budget Modification #1)**

RESOLUTION NO. 98-387

WHEREAS, the Tohono O'odham Department of Human Services is presently developing a Home Health Agency under IHS Grant #ISH002103-02 with the Indian Health Services; and

WHEREAS, Legislative Council, through Resolution No. 98-267, approved year two budget in the amount of \$180,050.00; and

WHEREAS, a modification to the budget justification is submitted for review and approval by the Department of Human Services, Division of Community Health Services to include Home Health Aides, CHR, CHS and Sr. Services staff in Tuition and Registration line item for staff development training.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:

- 1. It hereby approves the amendment and authorizes expenditures in accordance with the attached budget modification #1 submitted by Community Health Services.**
- 2. The Tohono O'odham Nation Officials, to wit: the Chairman and Vice Chairman and any designated Official are hereby authorized to negotiate and execute contracts associated with this grant and to expend funds when received.**

The foregoing Resolution was passed by the Tohono O'odham Council on the 17TH, day of SEPTEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,813.0 FOR; -0- AGAINST; -0- NOT VOTING; and 114.0 (06) ABSENT, pursuant to the powers vested in the Council by Section 1 (f) Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
