(FY 1998 Food Distribution Program-One Time Nutrition Education Funding  
- October 01, 1997 - September 30, 1998)**

**RESOLUTION NO. 98-388**

**WHEREAS, the Tohono O'odham Nation is presently operating the Food Distribution Program under an FY 1998 Grant with the United States Department of Agriculture; and**

**WHEREAS, one time funding in the amount of \$1,815 is available from FY98 FDIPIR Nutrition Education funds; which are funds above and beyond the general administrative funds; and**

**WHEREAS, any amendments affecting the funding or funding levels of the grant shall be submitted for review and approval by the Tohono O'odham Legislative Council; and**

**WHEREAS, a budget for use of the one time nutrition education funding has been submitted for review and approval by the Food Distribution Program.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 1. It hereby approves the Food Distribution Program Nutrition Education budget and authorizes expenditures in accordance with the attached budget submitted by the Food Distribution Program.**
- 2. The Tohono O'odham Nation's officials to wit: the Chairman and Vice Chairman and any designated official are hereby authorized to negotiate and execute the grant.**


**The foregoing Resolution was passed by the Tohono O'odham Council on the 17TH, day of SEPTEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,813.0 FOR; -0- AGAINST; -0- NOT VOTING; and 114.0 (06) ABSENT, pursuant to the powers vested in the Council by Section 1 (f) Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
