

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Accounting Department's Modification #3)**

**RESOLUTION NO. 98-392**

**WHEREAS, the Chairman of the Nation has filled the position of General Services Administrator for purposes of implementing the Executive Branch Administrative Plan; and**

**WHEREAS, the Administrative Plan reorganizes those programs operating under the Nation's indirect cost recovery provisions into a General Services Administration; and**

**WHEREAS, the Accounting Department has prepared a modification of its FY 98 budget to eliminate the Chief Financial Officer's position; and**

**WHEREAS, the proposed modification does not require a reallocation of personnel or operational fund, but does require a reallocation between established position; and**

**WHEREAS, sufficient funds exist as a result of vacant positions to fund the necessary salary adjustment; and**

**WHEREAS, the modification has been presented to the Budget and Finance Committee for review and recommendation.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby approves the attached budget modification #3 of the Accounting Department as attached, including:**


- 1. Adjustment of the Treasurer's salary as reflected in the attached modification #3.**
- 2. The elimination of the Chief Financial Officer's position as reflected in the attached modification #3.**

**BE IT FURTHER RESOLVED that these changes are effective upon the adoption of this resolution and are authorized as recurring expenses for the fiscal year 1999 base budget of the Executive Branch.**

11 **6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
