

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Confirmation of the Appointment of Newlon Dickson Benner as Treasurer  
of the Tohono O'odham Nation)**

**RESOLUTION NO. 98-393**

**WHEREAS, the Constitution of the Tohono O'odham Nation provides for the position of Treasurer to be appointed by the Chairman of the Nation and to be confirmed by the Tohono O'odham Council; and**

**WHEREAS, the Chairman of the Nation with the assistance of the Budget and Finance Committee, has conducted a search for the most qualified person to assume the position of the Nation's Treasurer; and**

**WHEREAS, Mr. Newlon Dickson Benner was selected as the best candidate and has accepted the appointment when offered by the Chairman of the Nation.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the appointment of Mr. Newlon Dickson Benner by the Chairman of the Nation is hereby confirmed.**

**BE IT FURTHER RESOLVED that Mr. Benner shall serve at the pleasure of the Chairman.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 18TH day of SEPTEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,737.0 FOR; 190.0 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 2 (e) of Article VII of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
