

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Confirmation of the Appointment of Richard Clifton as Director
of Public Safety for the Tohono O'odham Nation)**

RESOLUTION NO. 98-394

WHEREAS, the Administrative Plan of the Executive Branch provides for the position of Director of Public Safety to be appointed by the Chairman of the Nation and to be confirmed by the Tohono O'odham Council; and

WHEREAS, the Chairman of the Nation with the assistance of the Domestic Affairs Committee of the Legislature, has conducted a search for the most qualified person to assume the position of the Nation's Director of Public Safety; and

WHEREAS, Mr. Richard Clifton was selected as the best candidate and has accepted the appointment when offered by the Chairman of the Nation.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the appointment of Mr. Richard Clifton by the Chairman of the Nation to the position of Director of Public Safety is hereby confirmed.

BE IT FURTHER RESOLVED that Mr. Clifton shall serve at the pleasure of the Chairman.

The foregoing Resolution was passed by the Tohono O'odham Council on the 18TH day of SEPTEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,677.0 FOR; 250.0 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 2 (e) of Article VII of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
