

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the FY 1999 Budget for the Tohono O'odham Judicial  
Branch and Appropriating Funds in the amount of \$4,916,506)**

**RESOLUTION NO. 98-395**

**WHEREAS, the 1998 fiscal year ends at midnight, September 30, 1998 and all  
spending authority granted under the 1998 budgets ends at that time; and**

**WHEREAS, the continued operation of the Judicial Branch of the Tohono O'odham  
Nation requires adoption of an operating budget, the grant of spending  
authority and the appropriation of funds for FY 1999; and**

**WHEREAS, the Judicial Branch of the Nation has prepared and presented a budget  
that reflects the need of the Branch, said budget is attached hereto and  
incorporated by reference; and**

**WHEREAS, the Judicial and the Budget and Finance Committees of the Legislative  
Council of the Tohono O'odham Nation have reviewed this budget and  
recommends its approval and adoption.**

**NOW, THEREFORE, BE IT RESOLVED by the Legislative Council of the Tohono O'odham  
Nation that it approves the FY 1999 budget submitted by the Judicial  
Branch.**

**BE IT FURTHER RESOLVED that funds in the amount of \$4,916,506., are appropriated  
and authorized to be expended from sources of funding approved by this  
Council for support of the FY 1999 budgets of the Tohono O'odham Nation.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 18TH, day  
of SEPTEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,785.0  
FOR; 142.0 AGAINST; -0- NOT VOTING; and (02) ABSENT, pursuant to the powers vested  
in the Council by Section 1 (d)(2) & (3) Article VI of the Constitution of the Tohono  
O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and  
approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March  
6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
