

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 1999 Legislative Branch Budget)**

RESOLUTION NO. 98-397

WHEREAS, the FY 1998 Legislative Branch Budget will end at midnight September 30, 1998 and all spending authority granted under Fiscal Year 1998 will end at that time; and

WHEREAS, the Legislative Branch has prepared and submitted for review and approval their FY 1999 Budget; and


WHEREAS, on August 13, 1998 the Budget and Finance Committee did review the FY 1999 Legislative Branch Budget.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves the FY 1999 Legislative Branch Budget in the amount of \$2,579,043.00.

BE IT FURTHER RESOLVED that funds in the amount of \$2,579,043.00 be appropriated from the General Revenue Account.


The foregoing Resolution was passed by the Tohono O'odham Council on the 18TH day of SEPTEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,412.0 FOR; 442.0 AGAINST; 73.0 NOT VOTING; and (05) ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2) & (3) Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
