

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the FY 1999 Commerce Committee Budget)**

RESOLUTION NO. 98-399

WHEREAS, the Commerce Committee has submitted a budget for consideration by the Tohono O'odham Legislative Council for purposes of attending meetings with the State, National Indian Gaming Association (NIGA) and other Indian gaming related conferences and/or meetings; and


WHEREAS, the Commerce Committee twelve-month budget submitted in the amount of \$50,000.00 is effective October 01, 1998 to September 30, 1999; and

WHEREAS, the budget will be made part of the Operating Expense of Desert Diamond Casino.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby approves the Commerce Committee twelve-month budget in the amount of \$50,000.00.

The foregoing Resolution was passed by the Tohono O'odham Council on the 18TH, day of SEPTEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,414.0 FOR; 513.0 AGAINST; -0- NOT VOTING; and (05) ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
