

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Adoption of the Nursing Home Fiscal Year 1999 Budgets and Appropriating  
Funds from the Nursing Home Reserve)**

**RESOLUTION NO. 98-402**

**WHEREAS, the Tohono O'odham Nation has by previous legislation provided for a reserve to fund the necessary planning of the Nursing Home Project and administration; and**

**WHEREAS, the Executive Branch has prepared and presented the FY 99 Budget for the Nursing Home to continue activities of project; and**

**WHEREAS, sufficient funds remain in the established reserve to fund the budget as presented.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the Fiscal Year 1999 budget of the Nursing Home is hereby adopted, and is authorized to be expended accordingly.**

**BE IT FURTHER RESOLVED that the amounts required by the budget shall be appropriated from the established Nursing Home reserve.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 18TH day of SEPTEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,737.0 FOR; -0- AGAINST; -0- NOT VOTING; and 190.0 (06) ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
