

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the spending of Chukut Kuk District Economic
Development Funds)**

RESOLUTION NO. 98-406

WHEREAS, the Tohono O'odham Nation has given each district \$100,000 for economic development; and

WHEREAS, each district must come up with a spending plan to be approved by the Tohono O'odham Legislative Council; and

WHEREAS, Chukut Kuk District has created Chukut Kuk Enterprise, Inc. (resolution #98-28) as the legal entity responsible for all of the District's businesses; and


WHEREAS, Chukut Kuk District Council has approved Chukut Kuk Enterprises, Inc. 1999 Plan; and

WHEREAS, Chukut Kuk District Council has approved the spending of its Economic Development Funds of \$118,000 by Chukut Kuk Enterprises, Inc.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the use of Chukut Kuk District Economic Development funds.


The foregoing Resolution was passed by the Tohono O'odham Council on the 18TH day of SEPTEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,415.0 FOR; -0- AGAINST; 322.0 NOT VOTING; and 190.0 (06) ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
