

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Sells District F.Y. 99 Budget)**

RESOLUTION NO. 98-407

WHEREAS, the Tohono O'odham Legislative Council's Budget and Finance Committee did review the Sells District F.Y. 99 Budget in the amount of \$557,871.57; and

WHEREAS, the budget amount is the same as the gaming revenue distribution; and

WHEREAS, the Sells District Council approved the budget by resolution SD-32-98.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the Sells District Council F.Y. 99 Budget in the amount of \$557,871.57.

The foregoing Resolution was passed by the Tohono O'odham Council on the 18TH day of SEPTEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,737.0 FOR; -0- AGAINST; -0- NOT VOTING; and 190.0 [06] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


