

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Well Maintenance Program FY'98 Budget Modification #2)**

RESOLUTION NO. 98-409

WHEREAS, the Well Maintenance Program provides service and maintenance of stock and private wells and water storage tanks not maintained by the Tohono O'odham Utility Authority water system; and

WHEREAS, upon review of expenditure report for the Program it has been discovered that there is a shortage of funds allocated for the Supplies-other and the Office & Communication Equipment line items; and

WHEREAS, in fiscal year 1998, the Well Maintenance Program has incurred costs in line item 752 Office & Communication Equipment, although this line item was not included in the budget; and

WHEREAS, the Well Maintenance Program would like to correct this oversight by creating an Office & Communication Equipment line item and by utilizing savings from the Salaries line item to satisfy the overages.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves budget modification #2 for the Well Maintenance Program by creating an Office & Communication Equipment line item.

BE IT FURTHER RESOLVED that \$3,500 be transferred from the Salaries line item for distribution to cover the shortages in the Office & Communication Equipment and Supplies-other line items.

The foregoing Resolution was passed by the Tohono O'odham Council on the 18TH day of SEPTEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,737.0 FOR; -0- AGAINST; -0- NOT VOTING; and 190.0 [06] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
