

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Supporting Gu Achi District FY-99 Budget)**

RESOLUTION NO. 98-414

WHEREAS, the Gu Achi District Council on September 18, 1998 approved the FY-99 Budget in the amount of \$557,871.57 from the gaming revenues of the Tohono O'odham; and

WHEREAS, gaming revenue monies for Gu Achi District FY-99 will be deposited in account #235270939 with Bank of America, Tohono O'odham Branch 8091 in Sells, Arizona; and


WHEREAS, the Gu Achi District Council understands that any budget modification throughout FY-99 is at their discretion; and

WHEREAS, any amendments to the FY-99 budget that includes new monies and will involve a separate line item not within the FY-99 district budget shall be approved by the Tohono O'odham Legislative Council.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council has reviewed the Gu Achi District Council FY-99 budget and approves the same.

The foregoing Resolution was passed by the Tohono O'odham Council on the 23RD day of SEPTEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
