4 **WHEREAS, at a Special Legislative Council Session on September 23, 1998 the**
5 **Pisinemo District did present the District FY-99 Budget; and**

6 **WHEREAS, the Tohono O'odham Legislative Council did review the proposal of the**
7 **Pisinemo District; and**

8 **WHEREAS, the Tohono O'odham Legislative did determine that there was sufficient**
9 **fun**
10 **ds in the Nation's Distribution of \$557,871.57 and the Pisinemo**
11 **District Money Market Account 235267027 to support this proposal; and**

12 **WHEREAS, the Pisinemo District Council did approve their FY-99 Budget through**
13 **Pisinemo District Council Resolution 98-11, dated September 15, 1998.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council**
15 **does approve the FY-99 Operating Budget of the Pisinemo District in the**
16 **amount of \$669,449.00.**

17 **BE IT FURTHER RESOLVED that the amount of \$292,981.57 (*\$557,871.57 (Gaming***
18 ***Distribution) less \$264,890.00 (amount applied to 99 District Budget) has***
19 **been identified for investments by the Pisinemo District Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Council on the 23RD. day**
21 **of SEPTEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,927.0**
22 **FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the**
23 **Council by Section 1(d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham**
24 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by**
25 **the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**
26 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
