RESOLUTION NO. 98-419

WHEREAS, the Executive Branch has prepared and presented its fiscal year 1999 Base Budget to the Tohono O'odham Legislative Council; and

WHEREAS, certain budget appropriations of the Executive Branch FY 98 Base Budget have not been completely expended, specifically:

Administrative Provisions - Audit	\$270,280.00
Administrative Provisions - Annual Leave Reserve	<u>393,525.31</u>
Total	\$ 663,805.31; and

WHEREAS, the Executive Branch requests that these amounts be re-authorized and made available for fiscal year 1999; and

WHEREAS, of the amount identified for the Annual Leave Reserve, \$93,525.31, will be used to offset the additional requirements of the Executive Branch Supplements.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the Executive Branch's request for re-authorization and carry forward of its FY 98 unexpended funds in the total amount of \$663,805.31 is hereby approved, and is authorized to be expended as proposed in the attached budgets presented.

BE IT FINALLY RESOLVED that \$93,525.31 of the Annual Leave Reserve carry forward is hereby approved to offset the additional requirements of the Executive Branch Supplement request.

The foregoing Resolution was passed by the Tohono O'odham Council on the 23RD, day of SEPTEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


