

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the FY 1999 Budget for the Early Childhood Head Start - Child Care  
and Development Fund for Grant Year 1996 Funds)**

**RESOLUTION NO. 98-422**

**WHEREAS, the Tohono O'odham Nation is presently operating the Early Childhood Head Start Center and Day Care Centers for its young members and providing for their welfare through various programs and services designed to meet their special needs; and**

**WHEREAS, the Department of Health and Human Services, Administration for Children and Families has awarded to the Tohono O'odham Nation appropriations under the Omnibus Budget Reconciliation Act of 1990, P.L. 101.508; and**

**WHEREAS, the Tohono O'odham Legislative Council is desirous to continue to provide Child Care Services to its young tribal members; and**

**WHEREAS, the Early Childhood Head Start Program of the Tohono O'odham Nation has submitted for review and approval the proposed Child Care and Development Fund budget for Grant Year 1996 Funds.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby approve the Child Care and Development Fund FY 1999 Budget in the amount of \$360,848.00 for Grant Year 1996 Funds.**

**BE IT FURTHER RESOLVED that the duration of this budget will be from October 01, 1998 to September 30, 1999.**

**BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's Officials to wit: the Chairman, and any designated officials are hereby authorized to negotiate and execute the contract, provided however, that any amendments affecting the funding levels of the contract shall be submitted for prior approval by this Council.**


