

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 1999 Budget for the Early Childhood Head Start - Child Care
and Development Fund for Grant Year 1998 Funds)**

RESOLUTION NO. 98-424

WHEREAS, the Tohono O'odham Nation is presently operating the Early Childhood Head Start Center and Day Care Centers for its young members and providing for their welfare through various programs and services designed to meet their special needs; and

WHEREAS, the Department of Health and Human Services, Administration for Children and Families has awarded to the Tohono O'odham Nation appropriations under the Omnibus Budget Reconciliation Act of 1990, P.L. 101.508, and under the Personal Responsibility and Work Opportunity Reconciliation Act of 1996, P.L. 104-193, to conduct a Child Care and Development Fund Program; and

WHEREAS, the Tohono O'odham Legislative Council is desirous to continue to provide Child Care Services to its young tribal members; and

WHEREAS, the Early Childhood Head Start Program of the Tohono O'odham Nation has submitted for review and approval the proposed Child Care and Development Fund budget for Grant Year 1998 Funds.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby approve the Child Care and Development Fund FY 1999 Budget for:
Grant Year 1998 - Mandatory Funds in the amount of \$535,427.00; and
Grant Year 1998 - Discretionary Funds in the amount of \$147,848.00.

BE IT FURTHER RESOLVED that the duration of this budget will be from October 01, 1998 to September 30, 1999.

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's Officials to wit: the Chairman, and any designated officials are hereby authorized to negotiate and execute the contract,

provided however, that any amendments affecting the funding levels of the contract shall be submitted for prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 23RD day of SEPTEMBER, 1998 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
